I have tried to summarize some important facts in this letter, with the help of Cristina Mandrini (in CC), who also provided the English translation of the statement issued a few days ago by our National Academy of Sciences.

Motivated by this context and its negative effects upon us, I have added a request to the information provided. This concerns the reduction of some of our debts with IAU. If the proposed gesture through an exceptional reduction is achievable, or any other possibility you may offer, it may be good for the morale of our colleagues, because our economic situation has worsened with the latest inflationary jump.

We highly value the benefits of IAU for Argentina and hope to be better contributors in the future.
